## GENERAL WARRANTY STATEMENT

Encore product warranty is there to protect the consumer against unknown defects in material or workmanship. Essentially that the product was assembled correctly with components meeting our design criteria.

From time to time issues can and do arise where the product may have a premature component failure because of assembly errors, design, or an individual componential function. Encore seeks to provide a warranty that protects the customer from defect but also protection to the manufacturer from normal use conditions that cause failure.

During normal use the components will be subject to weather, dirt and physical damage that will reduce the life of these components. The effects of sunlight, dirt, sand, water, oil, gasoline, fertilizer, vibration, rough terrain, impacts, transportation, improper maintenance or adjustments are not considered warrantable. An authorized Encore Distributor or Dealer upon product and/or component inspection will submit claim for approval. Encore retains the right to accept and approve or reject warranty submittals. Encore also retains the right to review a component prior to warranty approval or rejection. Encore will reimburse the freight cost for any part returned per their request regardless of the warranty outcome.

The effects of the environment, operations, and maintenance have a significant impact on the overall life of the product and individual components. These effects should be considered when making any warranty decision. Good judgment and experience are essential to making correct decisions.
